## How to Apply to be a Notary Public in Nigeria



A notary public is appointed by the Chief Justice of Nigeria.

A notary's main functions are to administer oaths and affirmations, take affidavits and statutory declarations, witness and authenticate the execution of certain classes of documents.

#### THESE ARE THE REQUIREMENTS FOR NOTARY PUBLIC AS LISTED BY THE SUPREME COURT OF NIGERIA:

- (I). 3 copies of formal Application letter printed on the letter headed paper should be addressed to the Chief Registrar of the Supreme Court of Nigeria
- (ii). Curriculum vitae (CV) should be duly signed. 23 copies for Lagos state and 15 copies for other states.
- (iii). Photocopies of practicing fees receipt for 7 years preceding the date of application.

  Each payment must have been made as at when due on or before 31st of March of each year.
- (iv). 3 photocopies of Call to Bar Certificate.
- (v). 3 photocopies of Applicant's Incorporation Certificate with the Corporate Affairs Commission.

**Note:** Curriculum Vitae (CV) must be printed on the letter head with the name incorporated and contained on the CAC certificate.

#### **KEY HIGHLIGHTS OF THE STARTUP ACT 2022**

#### **▶** What You Should Know

Startups Now Require Additional Certification

Before a company can enjoy the benefits under the Act, it must obtain a Certificate known as the startup "label". By this, only entities with the startup label can be considered as startups for the purpose of the Act. The Act establishes a startup investment seed fund through which startups can access funding.



#### BENEFITS OF OBTAINING A STARTUP LABEL

- I. Eligibility to access special funds
- ii. Access to grants and loan administered by the Central Bank of Nigeria (CBN) and Bank of Industry (BOI)
- iii. Eligibility for possible four years tax exemptions and other tax incentives.
- iv. Eligible employees of a labelled startup are entitled Personal Income Tax exemption of 35% of the income of the employee for a period of two years from date of engagement. Etc.

#### **ELIGIBILITY FOR GRANT OF STARTUP LABEL**

According to the Act, to be labelled a startup, the entity must be registered as a Limited Liability Company under the Companies and Allied Matters Act 2020.

The startup must have been in existence for a period of not more than 10 years from the date of Incorporation.

It must have at least one Nigerian as a co-founder.

Its business object must include: "innovation, development, production, improvement, and commercialisation of a digital technology innovative product or process".

The Startup Act was signed into law on the 19th day of October 2022.



# ARIWOOLA AS





The swearing in of Mr Ariwoola as CJN followed his confirmation by the Senate on 21 September Three months after his appointment by the President.

President Muhammadu Buhari has sworn in Olukayode Ariwoola as substantive Chief Justice of Nigeria at the Council chamber of the State House, Abuja, on Wednesday.

The News Agency of Nigeria (NAN) reports that the swearing in of Mr Ariwoola followed his confirmation by the Senate on 21 September three months after his appointment by the president.

Mr Ariwoola took the judicial oath of office In a brief ceremony shortly before the commencement of the weekly virtual meeting of Federal Executive Council (FEC), chaired by the president.

NAN reports that the event was witnessed by Vice-President Yemi Osinbajo, some cabinet Ministers, other justices of the Supreme Court, the governors of Oyo and Ondo States, Seyi Makinde and Rotimi Akeredolu respectively.

Mr Ariwoola was appointed as acting CJN on 27 June, following the resignation of Justice Tanko Muhammad, on health grounds.

Mr Ariwoola was appointed a justice of the Supreme Court on 22 November, 2011 by President Goodluck Jonathan. He is an indigene of Iseyin in Oyo State.

Speaking to State House correspondents after the swearing in, the CJN appealed to politicians in the country to allow the judiciary function properly as the 2023 elections approach while promising reforms at the apex court.

Mr Makinde, who also spoke to the correspondents, expressed gratitude on behalf of the people and government of Oyo state to the president.

## EFCC To Take War Against Money Laundering To Lawyers, Accountants & Others


The Economic and Financial Crimes Commission (**EFCC**) says ahead of the 2023 elections, it will take the war against money laundering by politicians to lawyers, accountants, professionals and other designated non-financial businesses and professions (DNFBPS). The Chairman of the Commission, Abdulrasheed Bawa said this on Tuesday 25th October, 2022 at a workshop on financial crimes reporting organised by the Commission for some selected journalists in Lagos. Bawa said the commission was stepping up its investigations of the DNFBPS through its Special Control Unit Against Money Laundering (SCUML) under the newly enacted Money Laundering Prohibition and Prevention Act, 2022."There are certain provisions of this new law that I believe will affect you directly or indirectly. One is the secrecy of financial transactions. The new law criminalizes the operations of numbered accounts and also mandates financial institutions to ascertain the beneficial owners of accounts before opening such accounts.

"There is a more robust requirement for due diligence and reporting obligation by financial institutions and non-financial businesses and professions to the SCUML," he added. On the 2023 general elections, Bawa said the commission was beaming its searchlight on some politicians. He also said that the commission was taking an interest in the activities of some lawyers, accountants, tax consultants, real estate agents, construction companies, car dealers, precious stone dealers and some others as its investigations showed that they had become gatekeepers of money laundering. Bawa said, "we can't afford to have criminals hijacking our own political process. if they have some funds that they want to channel from there, we have to block them...very important and very critical, because the work we are doing is for the betterment of this country and we need to ensure that we have only legitimate sources of funds in our political process so we can elect our right leaders."But what we have seen time and time again is that some funds that are finding their way to lawyers' accounts are monies taken there for the purpose of laundering and we have quite a number of cases to show for it".

"They can hide under the guise of payment of fees to do that but at the end of the day, investigations will show whether the payment is for legal fees or otherwise. they are getting smarter, and we too are getting smarter. Luckily for us, we have Polygraph and if you consent to it, we do a polygraph and you will tell us the truth." We have seen for instance a legal practitioner that he is the one paying for tickets, school fees, and almost everything for his client so what are we talking about here and it's not something peculiar to Nigeria and that's why we say Nigeria should not be left out in global best practises regarding legal practitioners making currency transaction reports on their clients activities. Bawa also revealed that the EFCC had recorded over 2,701 convictions as at October 7, 2022. He said, "In 2021, the commission secured 2,220 convictions. This has jumped to 2,701 by October 7, 2022. Assets running into several billions of naira have also been recovered by the commission. In spite of this, we are not resting on our laurels because there is more ground to be covered. we believe more needs to be done to deter citizens from getting involved in financial crimes and discourage the theft of public resources."It is for this reason we are intensifying our public enlightenment engagements, which in a few weeks time will witness the formal launch of the EFCC radio."

#### STRIKING OUT OF AN APPEAL: END OF THE ROAD?

#### 1.00 INTRODUCTION

1.01 A party who is dissatisfied with the decision of a Court would normally appeal against such a decision. However, such appeal, when filed, can only be determined on the merits by the appellate Court if the appeal is found to be competent. Where the appeal is found to be incompetent, the court would usually strike out and not dismiss the appeal, the same not having been considered on the merits. See NWAOHA V. C. O. P (2018) LPELR — 44214 (SC). Even where the word "dismiss" was used in terminating the appeal, such "dismissal" not being on the merits is in effect regarded as mere striking out. See UNION BANK OF NIG. PLC V. PETRO UNION OIL & GAS LTD & ORS (2021) LPELR - 56671 (SC).

1.02 There may be several procedural defects that may bring about such incompetence including: failure to obtain leave to appeal when such leave is required: *EMETUMA & ORS V NWAGWU & ORS (2022) LPELR - 5686l(SC)*; filing the notice of appeal outside the statutory time frame without obtaining an extension of time: *STEPHEN V. STATE (2020) LPELR- 57336 (SC)*; *IHENACHO & ORS V. EGBULA & ORS (2021) LPELR - 55931 (SC)*; failure to properly sign the notice of appeal: *RAJI V. UNILORIN & ORS (2018) LPELR - 44692(SC)*; etc.

**1.03** Upon the striking out of such appeal, the Appellant "*loses*" and the Respondent "*wins*". The question however is: What is the legal import of such "*victory*" and "*loss*"?

#### 2.00 END OF THE ROAD?

- 2.01 Like any other contest, if the losing party remains where he fell, that is the end of the journey. But can the losing Appellant rise and resume the fight afresh? Having regard to the rigorous processes and length of time involved and even judicial energy expended in prosecuting an appeal up to the level where the appeal is heard and the judgment striking out the same is delivered, the usual feeling would be that the Law would loath to permit the aggrieved party coming up again with a fresh appeal. But is this the position of the Law?
- 2.02 In the recent decision of the Supreme Court In OPTIMUM CONSTRUCTION & PROPERTY DEV. LTD V. AKE SHAREHOLDINGS LTD (2021) LPELR 56229 (SC) the apex court summed up the law as follows:

"In situations such as this, the proper course open to a party who desires to appeal is to commence afresh the process of fulfilling the conditions precedent to filing a valid appeal by applying for extension of time to seek leave to appeal, leave to appeal and extension of time to appeal under a new appeal number. There is no law prohibiting the prospective appellant from doing so... The dismissal of an appeal on the ground that the required leave of Court to bring it was not first obtained before it was filed, does not determine the merit of the appeal and cannot finally determine the appeal so as to bar the exercise of a right of appeal to properly appeal..."

- 2.03 It follows therefore that an appellant whose appeal was struck out for incompetence can initiate and prosecute a fresh appeal in respect of the same decision against which he is aggrieved and such new appeal cannot be regarded as an abuse of Court process. See JAMES V. NIGERIAN ARMY (2018) LPELR 4608 (CA).
- 2.04 It would only require the appellant to seek and obtain an extension of time within which to initiate the fresh appeal. Happily, the trend of judicial thought and disposition is to grant such extension of time as the fact of the earlier botched appeal is even regarded as a genuine effort by the appellant to appeal against the judgment; See UNION BANK OF NIG. PLC V. PETRO UNION OIL & GAS LTD & ORS (2021) LPELR 56671 (SC). The Appellant would only need to satisfy the court that his proposed grounds of appeal are substantial as such leave to appeal would be refused where the grounds of appeal are adjudged non-substantial. See MINISTER OF PETROLEUM & MINERAL RESOURCES V. EXPOSHIPPING LINE (NIG) LTD (2010) LPELR 3189 (SC); OPTIMUM CONSTRUCTION & PROPERTY DEV. LTD V. AKE SHAREHOLDINGS LTD (2021) LPELR 56229 (SC).
- 2.05 However, it needs to be pointed out that there are certain proceedings including appeal proceedings that can only be initiated and concluded within specific statutory time frames. In respect of such proceedings therefore, it is safe to posit that once the incompetent appeal is struck out and the statutory time frame has run out, though the striking out would not be on the merits, the opportunity to initiate a fresh appeal would not exist as there would be no room for extension of time to appeal. In such situations any subsequent appeal would be statute barred. See for instance the provisions of S. 285 (7) and 285 (12) of the 1999 Constitution of the Federal Republic of Nigeria (as altered) under which appeals from decisions given in pre-election matters and election petitions must be heard and concluded within 60 days of the date of the decision appealed against. Outside that time frame the court loses jurisdiction to entertain such appeals. See PDP V. CPC & ORS (2011) LPELR 2909 (SC); PDP V. INEC & ORS (2014) LPELR 23808 (SC).

#### 3.00 CONCLUSION

3.01 In view of the foregoing, where an appeal is struck out for incompetence that may not be the end of the journey. An appellant who has good grounds of appeal and who has the resources and will to continue the fight can still go back to the drawing board and start afresh. In most cases, such second missionary journeys end up very fruitful and rewarding.

In SPDC (NIG) LTD V. ADIZUA (2014) LPELR — 23235 (CA) the appellant's appeal was struck out for having been initiated without leave. However a fresh appeal initiated and prosecuted by the same appellant against the same decision succeeded in SPDC (NIG) LTD V. ADIZUA (2018) LPELR - 444437 (CA).

The Human Rights Committee of the Nigerian Bar Association, Owerri chaired by Dr. Mrs Chioma Emuka visited the Federal Medical Centre Owerri on 26/10/2022 where Favour Chikpe and her son Miracle are being medically managed.

It was reported on major news platforms that the father of the 2-month-old baby Miracle allegedly beat up the baby with a hanger in Imo for disturbing his sleep and broke the

baby's arm leading to amputation.

Mr Amatobi was said to have assaulted little Miracle with a plastic hanger and broke the baby's arm for disturbing his sleep.

The ugly incident led to the amputation of the fractured arm at the Pediatrics ward of the Federal Medical Centre, FMC Owerri.

"The perpetrator, Mr. Confidence Amatobi, who hails from Amurie in Isu L.G.A used a plastic hanger on the baby, simply because he was crying that the 20-year-old mother left to ease herself. He used wood and elastic bands to tie the baby's hand when he saw that hand was broken and swollen.

"He locked up the mother and baby to prevent her from talking to neighbours or seeking help. He also took her phone from her. After two days she found her way out and sought help from her neighbours. The said Mr. Confidence was arrested by a vigilante but he escaped. By the time help came, the baby's hand was already decayed. The only option was to cut off baby Miracle's right hand from shoulder,"

## 22/23 New Legal Year:

## CJN TO SWEAR-IN 62 SENIOR ADVOCATES OF NIGERIA ON 28TH NOV. 2022

- \* Swearing In Ceremony Part Of Programmes To Usher In The Legal Year
- \* Says Date Shifted From 21st To 28th To Accommodate Supreme Court Programme Already Slated

The Chief Justice of Nigeria, Hon. Justice Olukayode Ariwoola, GCON, will swear-in 62 new Senior Advocates of Nigeria on Monday 28th November, 2022 at the main Courtroom of the Supreme Court. This was disclosed in a statement by the Director of Press and Information, Dr. Festus Akande.

He said the swearing-in ceremony is one of the several programmes planned to formally usher-in the 2022/2023 legal year of the Supreme Court of Nigeria.

Dr Akande, noted that going by our age-long tradition, during such programmes, the Honourable Chief Justice of Nigeria, will deliver a state-of-the Judiciary address which is ostensibly to highlight the performance of the Supreme Court, and by extension, the Nigerian Judiciary in the outgoing 2021/2022 legal year.

Out of the 174 applicants for the Rank of Senior Advocate of Nigeria in 2022, 62 were successful at the end of the rigorous exercise. Out of this number, 53 are advocates while 9 are academics.

"The earlier announced date of 21st November, 2022 to swear-in the newly appointed Senior Advocates had to be shifted to the new date of 28th November, 2022 in order to accommodate other programmes slated for the Court's new legal year.

"The Supreme Court commenced its annual vacation after a highly eventful and remarkably successful 2021/2022 legal year on Monday 23rd July, 2022. Though the Court had started sitting since 12thSeptember, 2022, the new legal year ceremony is now being formally held in line with our tradition", Dr. Akande said. All the programmes billed to mark the commencement of the new legal year are to begin at 10:00am in the main courtroom of the Supreme Court.
